## Application for Membership

Applicants for membership in POWA must meet certain minimum requirements based upon a set of criteria established by the Board of Directors. Each applicant must be sponsored by an Active Member or jointly by a Supporting Member and Active Member. Members cannot sponsor a relative; an unrelated third party is required to serve as sponsor. Each application will be reviewed by the Membership Screening Committee. After such review, the application will be presented, along with recommendations, if any, for acceptance, reclassification or rejection, to the Board of Directors for action.

To be eligible for "Active" classification, the member must be compensated for outdoor media services, with published production meeting criteria within the specified period (12 months) immediately prior to filing of application. Each applicant must demonstrate a continual and regular effort in professional outdoor media. **Proof of payment and publication must be submitted with the application.**
