# In Memoriam: Tom Fegely

POWA suffered a great loss with the passing of Tom Fegely in December.

Well known to both writers and readers alike, Tom was outdoors editor at The Allentown Morning Call for 25 years. His Focus on Nature weekly columns informed the public of the variety of wildlife and vegetation. He was host of the Call of the Outdoors television show and the Escape

to the Outdoors radio show carried by 375 stations; field editor and columnist for Field & Stream, Buckmasters, Whitetail Hunting Strategies and Whitetail News; and author of a number of books, including The Best of Focus on Nature, A Guide to Hunting Pennsylvania Whitetails and A Guide to Hunting Pennsylvania Turkeys.

Tom was a regular award winner for both writing and photography at Pennsylvania

# **POWA** board gives **OK** to amended directives

The Pennsylvania Outdoor Writers Association's Board of Directors approved the following additions to the organization's Board Directives during its meeting at The Nature Inn on Feb. 22, 2014. Only the proposed changes and additions are noted below in bold italics.

These edits will be brought for approval before by POWA members during the membership meeting on May 17, 2014.

Directives not listed below will not be amended. They have been removed due to space considerations within PowWow.

Any questions regarding clarification of the proposed changes should be forwarded to Dennis Scharadin, executive director, or Mark Nale, president, prior to the May 17 meeting.

#### 1) RESOLUTIONS

Resolutions except as provided for by constitution and bylaw amendments shall be submitted in duplicate to the President and to the Board for review 60 days in advance of any regular or special meeting. The resolution shall then be submitted to the membership by regular United States Postal Service mail, email or PowWow at least 30 days before the meeting when the proposed resolution may be voted upon. Approval of a resolution requires a 2/3-vote, a quorum being present.

#### 2) COMMITTEE REPORTS

Committee reports shall be submitted in a timely fashion in advance of each meeting to the Executive Director or other designate, in writing (including electronic transmittal). The Executive Director shall provide an acceptable format for the committee reports to each committee chair along with a reminder as to report due date.

#### 3) LIFE/HONORARYMEMBERSHIPS; MERITORIOUS SERVICEAWARD; PAST PRESIDENTS PLAQUE

• An *Honorary Member* shall be a resident of Pennsylvania who in an administrative capacity is engaged in the conservation of our natural

resources and is not otherwise eligible for membership in the association. Honorary Membership in POWA shall be on a yearly basis and may be extended from year to year by action of the Board of Directors. A member of long standing and service to the organization who is no longer able to fulfill the requirements of membership due to illness or incapacity may be granted Honorary Member status as well.

#### 6) POLICY STATEMENTS – POLITICAL PARTIES/COMMERCIAL PRODUCTS/ USE ASSOCIATION NAME

In keeping with the primary purpose of the Pennsylvania Outdoor Writers Association, Inc. (hereafter referred to as the "Association"), the following policy is adopted regarding the use of the Association's name, stationery, and other official emblems, documents, or functions:

#### • Endorsement of Political Parties or Candidates for Elective Offices:

- o The name of this Association shall not be used in any manner so as to construe the Association's endorsement of a political party, candidate for elective office, or party platform. Candidates for elective office shall be permitted to appear on scheduled programs or meetings of this Association for discussion and information relative to the interests of the Association. No campaign literature or other materials shall be distributed by the Association to its members, either by mail, email or by direct distribution at meetings.
- *Unauthorized Use of the Association's* Name:
  - o Upon evidence, presented and proven, that any member has violated any provision of the above policy, such case may be reviewed by the President, Officers, and/or Directors, or by such committee as the President

may appoint, and recommendations for further action may be presented to the membership for final decision as to disciplinary action or corrective measures necessary to preserve the good name and reputation of the Association.

#### 9) CIRCULATION OF MINUTES OF **DIRECTORS MEETINGS**

The recording secretary shall send a copy of the minutes of the board meetings to the Executive Director and President in advance of distribution to the officers/directors. The President approves the minutes before their further distribution. The Executive Director or other designate will provide the officers/directors with copies of the approved minutes. All meeting minutes will be published in PowWow.

#### 12) COMPENSATION OF OFFICERS

Officers/ directors / committee chairmen will be reimbursed for all reasonable expenses, such as telephone calls, postage, travel, etc. incurred in the performance of their duties. Expenses in excess of \$100

must be approved by the president or his/her designate. Accurate reports/ receipts must be provided to the Association.

#### 14) DEFINITION OF SUPPORTING **MEMBERS**

Supporting members will be confined to single companies or firms or to representatives of multiple companies or firms; however, representatives of multiple companies or firms can only represent POWA supporting members at the association's activities.

#### 17) CORE CRAFT AWARDS

POWA will stand ready to sponsor core craft awards, if there is no sponsoring supporting member. This is to include the plaque and the \$150 award payment. The core craft awards to be offered every year:

- Best Newspaper Column
- Best Newspaper Feature
- Best Magazine or Regional

Newspaper Column including eZines

- Best Magazine or Regional Newspaper Feature including eZines
- Best Published Newspaper Photograph, Color or Black & White
  - Best Published Magazine

Photograph, Color or Black & White

• Best Published Art, Black & White to include illustrations or cartoons

On alternating years:

- Best Radio / TV Program
- Best Book including eBooks POWA should always seek

supporting members to sponsor all contests.

#### 20) SUPPORTING MEMBER **BREAKOUT DAY FEES**

A\$45 display fee will be required from all supporting members displaying during breakout day. The display fee may be adjusted or waived at the discretion of the board.

#### 21) SUPPORTING MEMBERSHIP DUES IN EXCHANGE FOR MERCHANDISE

POWA has a structure in place for dues and mandates that supporting member dues be paid.

#### 23) CONFERENCE REGISTRATION **FEES**

Conference registration fees will be set at the discretion of the conference chairperson with approval of the Executive Director.

## **Executive Director's Report**

Congratulations, you have nearly survived this year's winter. So has POWA. Just as the temperatures are moving upward so is POWA. We have slight increases in both our Active and Apprentice membership, as well as Supporting membership. Best of all was the increased interest in potentially joining POWA by people who stopped at our booth at the Great American Outdoor Show.

Membership renewal completed with all but five of 159 members renewing. Active membership is at 139, Life membership is 9, Honorary membership is 2 and Apprentice membership is 3. One Life member, Tom Fegely, passed away. We have several new members, two that moved from Apprentice to Active and one applicant who reapplied for membership. Four more have requested applications – three are reapplying and one is a new applicant.

Supporting Member renewal is currently taking place. As of Feb. 18 we had 82 Supporting Members. Thirty-three have already renewed. The deadline for renewal is April 15. Three groups requested applications at the Great American Outdoor Show.

We had a booth and held an auction on the last Sunday of the show. Results were good considering most of the auction items were small. A new auction was held at the Lehigh Valley Sportsman Show the first weekend in March, which gave us another source of funding for grants to youth programs here in the state. ## Proposed membership changes, additions

As published in the Fall 2013 issue of *PowWow*, the Board of Directors approved changes and additions to POWA's membership categories.

The proposed membership types and criteria are listed in detail below and will be brought for approval before by POWA members during the membership meeting on May 17, 2014.

Any questions regarding clarification of the proposed changes should be forwarded to Dennis Scharadin, executive director, or Mark Nale, president, prior to the May 17 meeting.

#### **Membership Requirements:**

#### **Professional Contact & Communication**

An individual membership in the Pennsylvania Outdoor Writers Association is encouraged for those professional outdoor communicators who wish to improve their professional skills through craft improvement seminars, networking and personal interaction with other professionals in the field of outdoor communications.

Membership includes *PowWow* – the association's newsletter filled with craft improvement ideas, marketing information, tips for generating content ideas, member support and updates regarding POWA activities. Active, Associate and Student Members are encouraged to enter their works in competition for awards and honors in their fields. POWA awards and recognizes the best communicators with Excellence in Craft and Specialty Awards at each annual spring conference.

#### **Membership Levels**

A prospective POWA member may select from several levels of membership. The requirements for membership at each level with attendant dues schedule follows:

- Active Member, \$60\* Annual Dues
- •Associate Member, \$60\* Annual Dues
- Student Member, \$20 Annual Dues
- Supporting Member, \$100 Annual Dues
- Life Member (awarded by membership no annual dues)
- Honorary Member (awarded by membership no annual dues)

\*There is an additional \$10 processing fee for new Active and Associate members.

#### **Membership Qualifications**

Membership is based upon an applicant's professional contributions to the craft. Applications for membership are reviewed by a committee, employing the qualifying point scale. Professionals must demonstrate contributions that support outdoor recreation (hunting, fishing, camping, canoeing, trapping, hiking, etc.), natural history, nature tourism, outdoor education or conservation.

#### **Active Member**

Prospective Active Members of POWA must have received pay or compensation as professionals.

## Paid work can be in the following areas and must be outdoor-related:

- Newspaper, Magazine or Internet Journalist; Writer; Columnist; Editor; Designer, Publisher, or Staff Member for print or online publication(s)
- Freelance Writer on contract basis for print or online publications (e.g., newspapers, magazines, newsletters, eZines, etc.)
- Photographer (for print or online publications), Videographer or Producer
- Artist, Illustrator or Cartoonist published in any medium
- Webmaster of an outdoor-related website
- Film Editor, Scriptwriter, Director or Producer for a full-length film or video
- Television or Radio Personality with a regularly scheduled program
- Broadcast Scriptwriter, Editor, Photographer, Director or Producer in television or other aired video or radio production (periodic guest appearances do not qualify)
- Book Author (including eBooks), Editor, Designer or Publisher
- Educator, Presenter, Instructor or Nature Interpreter
- Full-time employee of a Nonprofit Conservation or Outdoor Recreation Agency, working with public relations, agency publications, public information, or disseminating outdoor or recreational information
- Full-time Employee of an Outdoor -related Industry, Agency, Business Association or Organization, including Public Relations and Marketing

• Outdoor-related businesses, agencies, organizations or associations that support POWA as supporting members

All applicants will be considered. The POWA Board of Directors recognizes that the field of professional outdoor communications continues to grow, expand and employ new technologies. The board encourages outdoor communicators to "make the case" for their membership on the application. The Board of Directors reserves the right to expand the communications categories to include newer fields.

An Active Member applicant must qualify for membership by earning at least 60 professional points in a calendar year. POWA expects that each applicant has received payment for their work. All applicants must provide samples of published/paid work with their applications. A letter from an editor stating that you have been remunerated for your work is sufficient.

#### **Point Scale**

#### 60 Points

- Awarded automatically for a full-time outdoor communicator in any media
- Automatic for an author of a book (30,000+ words) for three years
- One-hour TV or radio segment (1 Point per minute)

#### 30 Points

- Published Cover Photo, Cover illustration or full color art
- 30-minute TV or radio segment (1 Point per minute)

#### 20 Points

• Print or eBook of less than 30,000 words

#### 15 Points

• Full-color art or illustration published in print or online media

#### 10 Points

- Black-and-white illustration published in print or online media
- Any paid story, column, photo or video clip published in print or online
- Any 30-minute seminar, presentation or slide show

#### 6 Points

Blog of 500 or more words (if unpaid, the blog must receive 500 or more unique

views per month)

#### 3 Points

Short story, blog, or sidebar of 100 to

#### **Associate Member**

An applicant for Associate membership in POWA must have received pay for any of the accepted aspects of outdoor communication (as listed above), but has not yet produced the quantity necessary for Active membership. An Associate Member applicant must submit proof of payment received or income earned for approved works. A person may be an Associate Member for an indefinite period of time. An Associate Member has all the benefits of an Active Member, but is not eligible to vote or hold office.

#### **Student Member**

An applicant for Student membership in POWA must be enrolled in some capacity in an accredited secondary school, community college, college or technical school and have an interest in pursuing a full or part-time career in nature art, outdoor photography, outdoor writing, conservation, outdoor education or nature tourism. Student Members receive the same benefits

as Active Members, excluding the ability to vote or hold office.

#### **Supporting Member**

POWA welcomes and encourages businesses, agencies, marketing and advertising organizations, manufacturers and purveyors of outdoor products and other outdoor-related groups to become Supporting Members. Full-time employees of a for-profit business, agency, or organization related to the outdoors, wildlife conservation or nature related tourism may apply for POWA membership without the required point scale. Supporting members enjoy opportunities to highlight their products and services to other members of POWA through mailings and emails, at the yearly spring conferences, and in the newsletter. Supporting members are key to the fiscal stability of POWA and the POWA Excellence in Craft awards.

#### **Application Process**

Applicants for Active, Associate, or Supporting membership must be sponsored by an Active Member. No sponsor is necessary for a Student membership. Both applicant and sponsor must verify with their signatures that the applicant qualifies for membership. A member's signature on the application acknowledges that the prospective Active Member has met the 60-point minimum for the previous 12 months. The Executive Director may assist with matching applicants to sponsors.

All applications must be submitted on the approved form, which can be downloaded at www.paoutdoorwriters.com

Every applicant agrees to be bound by the principles of the organization, including the POWA Code of Ethics.

#### **Audits**

All POWA members must continue to meet membership criteria and requirements. From time to time, POWA members may be subject to audit and/or periodic credential review. Current Active Members who fail to meet the minimum requirements will receive a three-year grace period, during which voting rights continue. After 10 years of continuous Active membership, an Active Member will no longer be subject to credential audits.

#### **Membership Regulations**

The POWA Bylaws and the POWA Board of Directors regulate membership levels and qualifying criteria. The POWA Board of Directors also regulates, supplements and controls the application and audit process.


# Gogal Publishing's GPS app highlights conference waypoints for iPhone users

gathering will be held Thursday evening at a local restaurant. Enough time should be available for those wishing to get back on a stream.



\*Motion to accept the revised statements as printed in this issue. Cole/Isles. Approved.



Scharadin said an additional \$1,000 would suffice and be closer to compensation in the recent past. While the board agreed that an increase is warranted, it will first consult with the Treasurer to make sure an increase is financially prudent for the organization at this time.

7. Timing of elections, notices – Tabled. Open Discussion: Jeff Mulhollem suggested targeting scholarship funds for use as paid internships for up and coming outdoor writers in collage. Ralph suggested a student outdoor committee to examine how to identify and reach this new audience.

The board discussed ideas to increase the membership, boost retention and increase member satisfaction. Ideas included a request to the Game Commission to include a POWA application in an upcoming issue of Game News, creation of a ready ad slick and press release and increasing use and value of the POWA Facebook page. The board also intends to add more value to membership working to secure award sponsors in order to add more Excellence in Craft awards.

The board remains committed to maintaining positive momentum in growing the membership, and other upcoming work will include a mailing a letter and application to all state park naturalists.

# Proposed POWA Constitution & Bylaw amendments

The Pennsylvania Outdoor Writers Association's Board of Directors approved the following amendments to the organization's Constitution and Bylaws during its meeting at The Nature Inn on Feb. 22, 2014.

These edits will be brought for approval before by POWA members during the membership meeting on May 17, 2014. Any questions regarding clarification of the proposed changes should be forwarded to Dennis Scharadin, executive director, or Mark Nale, president, prior to the May 17 meeting.

# Constitutional Changes ARTICLE III – MEMBERSHIP

ADDED Applicants are reviewed by a committee based upon their professional contributions to the craft employing the qualifying point scale. Professionals must demonstrate contributions that support outdoor recreation (hunting, fishing, camping, canoeing, trapping, hiking, natural history, nature tourism, or conservation.

#### A. CLASSES OF MEMBERSHIP

- 2. **Associate Member**: (*REPLACED* There shall be two (2) categories of this classification, as follows:
- a. An Associate Member shall be an individual who has contributed extraordinary service to the Association, and who subscribes to the purposes of this Association, but who is not eligible for active membership by invitation of the Board of Directors.
- b. An Associate Member shall be an individual who was an active member for a minimum of five (5) years, but who is presently unable to meet the required qualifications as an active member. This individual may petition the Association to become an Associate Member, and this petition shall be referred to the Board of Directors for action. These persons elected to membership under this provision could remain an Associate Member for a maximum period of two (2) years from the date of acceptance to this category of membership. Associate members shall not have the right to vote, nor the right to hold

office. The total number of associate members, from both categories, shall not exceed 15% of the total number of active members.)

REPLACEMENT: An applicant for Associate membership in POWA must have received pay for any of the accepted aspects of outdoor communication but has not yet produced the quantity necessary for Active membership. An Associate Member applicant must submit proof of payment for or income earned for approved works. A person may be an Associate Member for an indefinite period of time. An Associate Member has all the benefits of an Active Member except he or she may not vote or hold office. A candidate for Associate Membership must be sponsored by an Active Member.

B. *REMOVED* (Apprentice Member: An Apprentice Member shall be a person who subscribes to the purpose and standards of this organization, but who, at the time of application, is not eligible for active membership. Such membership shall remain in force until they qualify for active membership or, for a maximum period of two (2) years from the date of acceptance as an apprentice member. Apprentice members shall be accorded all privileges of membership except the right to vote and the right to hold office.)

C. <u>ADDED</u> Student Member: An applicant for Student Membership in POWA must be enrolled in some capacity in an approved and accredited secondary school, junior college, college or technical school and have an interest in pursuing a professional career in nature art, outdoor photography, outdoor writing, wildlife conservation or nature tourism. Student Members have all the benefits of an Active Member except they may not vote or hold office. No sponsor is necessary for Student Membership.

D. Supporting Member: <u>REPLACED</u> (A Supporting Member shall be any organization, association, business or commercial firm which has a common interest in the purposes of this Association and desires to contribute to the accomplishment of such purposes. Such members may be admitted to membership upon approval of the Board of Directors and upon payment of dues. They shall have

all privileges of membership, but shall not have the right to vote or the right to hold office. The same Code of Ethics as POWA's general membership binds supporting members. Failure to comply will be grounds for forfeiture of membership.)

**REPLACEMENT:** POWA promotes and encourages businesses, agencies, marketing and advertising organizations, manufacturers and purveyors of outdoor products and other outdoor related groups to consider a supporting membership. Full-time employees of a for profit business, agency, or organization related to the outdoors, wildlife conservation or nature related tourism may apply for POWA membership without the required point scale. Supporting members enjoy opportunities to high light their products and services to other members of POWA, through mailings and emails, at the yearly spring conferences and in the newsletter. Supporting members are key to the fiscal stability to POWA and the POWA Excellence in Craft awards.

#### **Bylaw additions**

# SECTION NINE – MEMBERSHIP REQUIREMENTS

**Professional Contact & Communication** – An individual membership in the Pennsylvania Outdoor Writers Association is encouraged for those professional outdoor communicators who wish to improve their professional skills through craft improvement seminars, networking and personal interaction with other professionals in the field of outdoor communications.

Membership includes *PowWow* – the association's newsletter filled with craft improvement ideas, marketing information, tips for generating content ideas, member support and updates regarding POWA activities. Active, Associate and Student Members are encouraged to enter their works in competition for awards and honors in their fields. POWA awards and recognizes the best communicators with Excellence in Craft and Specialty Awards at each annual spring conference.

**Membership Levels** – A prospective POWA member may select from several levels of membership. The requirements for membership at each level with attendant

dues schedule follows:

- Active Member, \$60.00\* Annual Dues
- Associate Member, \$60.00\* Annual Dues
- Student Member, \$20.00 Annual Dues
- Supporting Member, \$100.00 Annual Dues
- Life Member, (awarded by membership – no annual dues)
- Honorary Member, (awarded by membership no annual dues)

\*There is an additional \$10.00 processing fee for new Active and Associate members.

Membership Qualifications – Membership is based upon an applicant's professional contributions to the craft. Applications for membership are reviewed by a committee, employing the qualifying point scale. Professionals must demonstrate contributions that support outdoor recreation (hunting, fishing, camping, canoeing, trapping, hiking, etc.), natural history, nature tourism, outdoor education or conservation.

Active Member – Prospective Active and Associate Members of POWA must have received pay or compensation as professionals and they need to be sponsored by a current Active Member. The Executive Director may assist in the recruiting of a sponsor for those desiring to join and lacking a sponsor.

## Paid work can be in the following areas and must be outdoor-related:

- Newspaper, Magazine or Internet Journalist; Writer; Columnist; Editor; Designer, Publisher, or Staff Member for print or online publication(s)
- Freelance Writer on contract basis for print or online publications (e.g., newspapers, magazines, newsletters, e-zines, etc.)
- Photographer (for print or online publications), Videographer or Producer
- Artist, Illustrator or Cartoonist published in any medium
- Webmaster of an outdoor-related website
- Film Editor, Scriptwriter, Director or Producer for a full-length film or video
- Television or Radio Personality with a

- regularly scheduled program
- Broadcast Scriptwriter, Editor, Photographer, Director or Producer in television or other aired video or radio production (periodic guest appearances do not qualify)
- Book Author (including eBooks), Editor, Designer or Publisher
- Educator, Presenter, Instructor or Nature Interpreter
- Full-time employee of a Nonprofit Conservation or Outdoor Recreation Agency, working with public relations, agency publications, public information, or disseminating outdoor or recreational information
- Full-time Employee of an Outdoor -related Industry, Agency, Business Association or Organization, including Public Relations and Marketing
- Outdoor-related businesses, agencies, organizations or associations that support POWA as supporting members

All applicants will be considered. The POWA Board of Directors recognizes that the field of professional outdoor communications continues to grow, expand and employ new technologies. The board encourages outdoor communicators to "make the case" for their membership on the application. The Board of Directors reserves the right to expand the communications categories to include newer fields.

An Active Member applicant must qualify for membership by earning at least 60 professional points in a calendar year. POWA expects that each applicant has received payment for their work. All applicants must provide samples of published/paid work with their applications. A letter from an editor stating that you have been remunerated for your work is sufficient.

#### **Point Scale:**

- 60 Points Awarded automatically for a full-time outdoor communicator in any media
  - Automatic for an author of a book (30,000+ words) for three years
  - One-hour TV or radio segment (1 Point per minute)
- 30 Points Published Cover Photo, Cover illustration or full color art
  - 30-minute TV or radio segment (1 Point per minute)
- 20 Points Print or eBook of less than 30.000 words

- 15 Points Full-color art or illustration published in print or online media
- 10Points—Black-and-white illustration published in print or online media
  - Any paid story, column, photo or video clip published in print or online
  - Any 30-minute seminar, presentation or slide show
- 6 Points Blog of 500 or more words (if unpaid, the blog must receive 500 or more unique views per month)
- 3 Points Short story, blog, or sidebar of 100 to 300 words

Application Process - Applicants for Active, Associate, or Supporting membership must be sponsored by an Active POWA Member. No sponsor is necessary for Student membership. Both applicant and sponsor must verify with their signatures that the applicant qualifies for membership. A member's signature on the initial application acknowledges that the prospective Active Member has met the 60-point minimum for the previous 12 months. The Executive Director may assist with matching applicants to sponsors. All applications must be submitted on the approved form, which can be downloaded at www.paoutdoorwriters.com.

Every applicant agrees to be bound by the principles of the organization, including the POWA Code of Ethics.

Audits – All POWA members must continue to meet membership criteria and requirements. From time to time, POWA members may be subject to audit and/or periodic credential review. Current Active Members who fail to meet the minimum requirements will receive a three-year grace period, during which voting rights continue. After 10 years of continuous Active membership, an Active Member will no longer be subject to credential audits.

Membership Regulations—The POWA Bylaws and the POWA Board of Directors regulate membership levels and qualifying criteria. The POWA Board of Directors also regulates, supplements and controls the application and audit process.

These new membership requirements supersede all previous requirements, and such should be noted regarding the Constitution and Bylaws.


## **Market News**

The vast majority of our stories are written and photographed by established freelancers or our editorial staff, though we are open to new story ideas and contributors. We publish six times a year in March, May, June, July, August and December. We also publish the annual C&K Beginner's Guide and Kayak Fish magazine. We publish original stories, photographs, videos and multimedia projects through our online portal, canoekayak. com. We rarely run unsolicited articles. It is best to email us a short, original, and very succinct query about your idea, the photos available to illustrate it, and your writing background/availability. Please read the magazine before sending a query. Your query should demonstrate that you're familiar with the magazine and the website, its editorial focus and tone, and its specific sections. C&K is written by and for people who are passionate about paddling. Queries should be tailored to one section of the magazine, or site, and sent to the assigning editor for that section: Managing Editor Dave Shively, dave@canoekayak.com: Gear, personality profiles, shoestring 'Dirtbag Diary' adventures, and news, trend and analysis pieces for front-of-the-book stories (250-500 words). Editor-in-Chief Jeff Moag, jeff@canoekayak.com: Features, photo galleries, Aquaphile Essays from the Field, Unfiltered and destinationbased pieces. Online Editor Charli Kerns, charli@canoekayak.com: Stories, photos and videos for the web. News and events, anything with a quick turnaround. Word length: 100-600 words. High-res photos and good quality video is a bonus. Photo Editor Aaron Schmidt, Aaron.Schmidt@ sorc.com: High-resolution, gallery-quality, non-doctored photographs of canoeing and kayaking expeditions, events and personalities.

**Bait Fisherman** is seeking articles on practically any topic that is "bait fishing" – the fish, the bait, techniques and locations.

Both fresh water and salt water pieces are sought. Though every



**American Trapper** is the voice of the National Trapper's Association. We are seeking to build our inventory of articles. Practically any topic that is "trapping" qualifies - the equipment, preparation, sets, furbearer behavior, line management, animal damage control and fur handling. Please, no calling articles. We use both long feature articles and shorts. I recommend most articles be in the 1,000- to 2,500word range. Shorts, of course will be 250 to 1,000 words. A good variety of photos and sidebars are a definite plus. Payment varies highly depending upon length, photo support, uniqueness and so on. Top pay is \$175 approximately 2 weeks after publication. Pennsylvania Angler & Boater, published bi-monthly, is the official fishing and boating magazine of Pennsylvania. As the Pennsylvania Fish & Boat Commission's state agency publication, it is the voice of the Commonwealth concerning matters related to fishing and boating, and to protecting, conserving and enhancing the state's aquatic resources. The magazine is a 64-page four-color self-cover with no advertising. Approximately 80 percent of the magazine's content is supported through contributions by non-commission authors and photographers. A partial list

of our needs includes: How-to articles on fishing and boating in Pennsylvania. Where-to articles that include details on how to fish in specific Pennsylvania waterways (or several waterways) and technically accurate how-to information. These should include hand-drawn maps or marked maps from published sources showing accesses, main roads, landmarks, parking and hotspots. Boating articles -How-to, where-to, fishing from a boat, recreational powerboating, paddling, repair, maintenance, trailering and technical topics. We like to publish articles that inform readers of the latest fishing and boating methods and trends. We consider only information that applies specifically to Pennsylvania. We do not publish pieces about using specific products or services. Articles that show the benefits of fisheries management applications, research results and studies. The benefits for anglers and boaters of cooperative efforts among the Commission and other government and private groups. Short Articles - We use articles of approximately 600 words with two or three photos for published onepagers. Subjects include fresh, sharply focused ideas on all aspects of the Commission and its mission, and angling and boating topics. Fish & Boat Commission activities across the state and how anglers, boaters and the environment benefit from the activities. Nostalgia, humor and "think" pieces - These articles must be about Pennsylvania fishing and boating. We also publish Pennsylvania-based historical articles, Pennsylvania-based fiction ("me and Joe" articles) and first-person accounts taking place in Pennsylvania. These articles must be rooted in the state's angling, boating or aquatic resources. We do not solicit product reviews or roundups, cartoons, poetry, games, puzzles or tournament coverage. We rarely publish articles that have appeared in other online or print publications. Articles should be aimed at anglers and boaters with intermediate-level to advanced-level skills. Published articles are between 600 to 2,500 words. Outdoor Writers Association conferences, but these were not his only honors. Others include two Distinguished Service Award from Lock Haven University and Lock Haven's Alumni Association; the Wildlands Conservancy Award of Distinction; the first Pennsylvania Outdoor Ambassador Award from PADCNR, PGC, DCED and PFBC; four Pennsylvania Associated Press Enterprise Awards; and "Communicator of the Year" by NWTF; and Eastern Sports & Outdoor Show Youth Mentor Award.

Tom also wrote youth books—on nature, organic gardening, recycling and deer and turkey hunting. Four of these books received awards by the National Science Teachers Association. On *Call of the Outdoors*, he frequently included youth-oriented programming on a regular basis with focus on young people.

Tom was a past president and a life member of POWA. He willingly mentored budding and veteran writers. Along with Betty Lou, he hunted 32 U.S. states and

internationally in places like Africa, Bulgaria and four Canadian provinces. After retiring from the newspaper business, Tom and Betty Lou moved to a home in Northampton County.

I first met Tom and Betty Lou when invited to a dove hunt near Carlisle where I met a group of POWA members, including the Fegelys. Later, when I joined the organization, in awe of such giants of the

outdoor writing world as the Bashlines, the Lewises, Keith Schuyler, Bob Clark and others, Tom and Betty Lou went out of their way to make Darla and me feel welcome; and we became great friends over the years. At the Professional Outdoor Writers Association conferences, we spent a lot of time together, along with other members of the "Pennsylvania Mafia" contingent.

Several other POWA members have paid tribute to Tom:

"Not only one of the greats among outdoor writers," wrote Marcus Schneck, "but also a model human being, who treated everyone with respect, dignity, kindness and generosity. And, on top of that, he left a huge legacy in readers and audiences awakened to the wonders of the natural world."

"Tom Fegely was an outstanding person whose goodness was reflected in his respect for the outdoors," added Doyle Dietz.

Tim Flanigan wrote, "Tom was a professional's professional. He excelled in everything he attempted. He never had a disparaging word to say about anyone, and no one ever disparaged him."

Rest in peace, Tom. You are missed.
